You're Gonna Need A Bigger Boat

Classic line from a classic movie, Jaws. There's good old Chief Brody, flinging bloody fish guts into the water when the mighty Great White they've been chasing after breaks the surface of the water for the first time. It's big—much bigger than

Brody thought it would be. He realizes they're in for a much bigger fight than he anticipated. Sure, he was out there, chumming the water in the hopes of drawing the shark in. But this beast looks to be more than they can handle. The same thing is happening right now in the paranormal community. In this case, the sharks that have broken the surface are a group known collectively as Debunkers. And they smell blood in the water.

Even the most tried and true believer has to admit, if only to themselves, that paranormal investigation shows from television to YouTube and TikTok—have, in recent years, swerved wildly from "reality" into "entertainment." It happens. People aren't going to be interested in things that don't entertain them. But what some are taking umbrage with is that fact that many of these shows are making unsubstantiated claims and, in some cases, manufacturing evidence and hoaxing.

Enter the Debunkers.

The Debunkers are a loose group of individuals who have taken to social media and YouTube, creating videos calling out various paranormal shows and para-celebrities (yes, they name names) and providing "evidence" of fakery and lies. It's fairly entertaining in and of itself, but it also gets somewhat brutal and personal. In turn, the shows and individuals who have been called out by the Debunkers have responded with claims of harassment and copyright infringement. And then things start to get really personal.

It should be noted that by and large, the Debunkers are not taking issue with claims of "this EVP says, 'help me'" or "I thought I saw a shadow." Rather, they are focusing on claims of doors repeatedly opening and closing on their own, demons being captured crawling out of the shadows, and suspect ways of alleged two-way spirit communication. We're talking extreme activity here. And it's being passed off as being real. So the whole "extraordinary claims require extraordinary evidence" thing rings true here. Personally, I think some of these groups threw that "evidence" out there simply to get views/likes without a thought as to what sort of repercussions might be waiting for them, just below the surface.

For me, any time I send a piece of "evidence" out into the ether, I simply say, "I can't explain this" and allow for my peers to analyze it. That's how it should be. If they have questions or put forward "normal" explanations, I don't dismiss those or get angry. And if someone does figure out that it wasn't a ghost after all, so be it. We live and learn.

The Debunkers are also starting to put forward a disturbing accusation. Namely that there are shows a para-celebrities that are basing their entire channels on creating hoaxes and passing them off as real. This has led to one Debunker to question the role that paranormal investigators have in enabling ignorance.

So a word of caution for those out there who are considering putting exaggerated claims out there for the sake of views: Don't be surprised when something bigger than you expected breaks the surface and starts coming for you.

Hosted by Ghost Hunters' Dustin Pari Live at the Southern Theatre




Ghost Hunters' Dustin Pari is going out on tour, so to speak, and I attended his presentation on April 17th at the Southern Theatre in Columbus, Ohio. Oddly enough, I only learned of Dustin's upcoming presentation a week prior to it taking place. It had not been widely promoted, for

some reason. I first met Dustin a little over 15 years ago on a *Ghost Hunters* group investigation at an old hospital in New Castle, PA. During that investigation, I managed to have a lengthy conversation Dustin and found hm to be a very honest, spiritual, and engaging person. So I knew his appearance at the Southern Theatre was not to be missed.

Columbus' Southern Theatre was the perfect setting for this type of intimate program, which was actually divided into 2 parts. For the first part, Dustin came out and was already in a very relaxed, humorous mood. He explained he was going to talk about his personal experiences and what he has learned over the years. Then, for the second part of the presentation, he would take questions from the audience, some of which had been sent in prior to the event.

Dustin began by sharing how he got involved with *Ghost Hunters* and doing investigations with TAPS. He basically lived in Providence, RI which is a stone's throw from Warwick, the home office of TAPS. Dustin admitted he was very persistent—contacting TAPS repeatedly with emails and general pleas to allow him to become an investigator. After some time, he was finally asked to join TAPS on a local investigation. Over time, Dustin eventually became a regular member of TAPS.



As his presentation continued, Dustin also shared with the audience his first ghostly experience. It happened when he was a young child and involved a shadow figure. Dustin told the audience that over time, he came to believe in the afterlife, following the death of his mother.

Dustin also discussed the history of written ghost stories, oral ghost history, the spiritual movement of the mid 1800s, Ouija boards and more. There were even video clips from his time on *Ghost Hunters International*. Dustin also displayed some apparitions that were captured with a special camera during filming the filming of GHI episodes in Brazil and Australia. To be honest, I personally thought it took some imagination to see what Dustin saw in those particular photographs. It was all very interesting, nonetheless.

Dustin wrapped up the first part of his presentation with a discussion about provoking spirits and demonic possession. Dustin was quick to point out that he felt one should always be respectful to ghosts. They were people, too, after all. It was also his personal belief that shows featuring provoking and people allegedly getting scratched by demons to be somewhat suspect.

During Act II, Dustin read questions from the audience that had been prepared beforehand. He even read my question; "Did you get pressured by your producers to "find evidence" in order to keep the program interesting?" His response was "absolutely not." He said Grant and Jason were both producers and stated there was no hocus pocus, per se and he never saw any faking taking place. Dustin did say that he couldn't speak to the credibility of any program that he was not involved with. The worst question of the evening was "Is a hot dog a sandwich?" It was around that time I thought it was time to wrap things up.

All in all, I found Dustin to be very candid and honest and it was a fun experience. I would suggest that anyone with an interest in the paranormal check the show out if Dustin comes to your town. He's covering 24 cities east of the Mississippi with a few stops in Canada. Visit his website for more information.





EQUIPMENT REVIEW: MOTION LIGHT BALLS

In a field were dropping hundreds of dollars on a singular device is the norm, every once in a while, something comes along that's so cheap as to make it sound too good to be true. Such is the case with Motion Light Balls, which many groups and reality shows are using as trigger objects to detect the presence of spirits.

Motion Light Balls come in a variety of sizes, but the most common ones are about 1.5" round pieces of clear plastic with a red on-off push button. Turning the ball on causes a series of small lights to flash inside the sphere for a few seconds before they turn off. Touching or creating any sort of vibration around the ball will cause the lights to flash again. The idea being that these devices, often marketed as ghost detection balls" or "ghost trigger balls," will flash its lights should a ghost touch or move it or cause a vibration in close proximity to itwith phantom footsteps, for example. One of these light balls will barely make a dent in your wallet-only about \$2.00 each. Of course, if the packaging has "ghost" written anywhere on it, you'll need to triple the price. Why the price difference? Because while some people are selling them as ghost detection devices, to the normal people out there, these are nothing more than cat toys, designed to entertain cats by emitting a series of flashing lights whenever they are touched or moved.

At this point, it would be very easy to simply dismiss these devices having any sort of place in paranormal research, but hear us



out: If this device is able to detect motion and/or react to something touching it, then it could potentially be used as a trigger object. Not on its own, mind you. But if had several light balls lined up down a hallway, along with other handheld devices (EMFs, for example) and the motion balls lit up at the same time there were spikes on the EMFs, that could mean something. With that in mind, we decided to test the motion balls out.

Unfortunately, that's where we ran into a bit of a problem. You see, the light balls that we tested really needed a hard push to get them to trigger—in some instances, even when we gave it a good whack, the lights never came on. And then, sometimes, after the ball was just sitting quietly by itself, the lights would flash.

So what gives? Well, it seems that the different motion balls we tested all came with some sort of trigger where, if left unattended, will cause the lights to briefly flash. It might be designed that way to try to

get a cat interested in playing again or simply just a way of letting us humans know we forgot to turn the motion ball off. Either way, the fact that these motion balls will start flashing without any external force being exerted on them means they shouldn't be used on investigations, as least not without secondary or even tertiary pieces equipment as backup.

FROM THE ARCHIVES

Recently, my home computer decided it didn't want to house any of my Ghosts Of Ohio files anymore and guit on me. Not fun. I was able to get everything back, though, but the files were thrown all over the place, leading to my having to go through them all in an attempt to sort things out and get them back where they belonged. The result was a lot of "what's the deal with this?", especially when it came to old photographs. That's when it dawned on me; I bet all our newsletter subscribers would get a kick out of these. And the From The Archives column was born.

The plan is to post a photograph, without context, and let everyone try to figure out just what's going on in it. Then you can scroll down a bit, and we'll let you know the history behind the photo.

Here's the first one for you. Only thing I'll tell you for now is that those are all members of The Ghosts Of Ohio in the photograph and it was taken in 2013 at Willis Woods.



So what do you think is going on? Are we trying to conjure something? Being forced to endure the world's saddest birthday party?

Actually, we were performing an experiment. Specifically, we were looking at the ideas of telekinesis and psychokinesis and how it might be possible for a "collective" to do such things. Put another way, no one in The Ghosts Of Ohio claims that they have the ability to move solid objects using the powers of their mind. We took that to mean that none of us had the "full" power to do that. After much consideration, we started asking ourselves "well, what is each of us had a small bit of telekinetic/psychokinetic ability. If we were to all come together and form a "collective" by all focusing on moving the same specific item, would we be able to move said item?

We started with several different solid objects such as small toys and balls, all agreed what we were going to focus on (i.e.; cause the ball to roll), and then all concentrated on nothing but that. All of the experiments were done in my basement with all the lights turned off and no one else in the rest of the house-so all distractions were eliminated.

I would love to say that the experiments were a success, and we were able to collectively send all sorts of objects flying through the air. But that didn't happen. No matter how hard we tried, we couldn't get any of the objects to budge even slightly.

So what about the picture? Well, that was taken when we decided to abandon the idea of moving a solid object and instead try moving something a little less solid—like a candle flame. Alas, that didn't work, either. But it was fun trying and led to a whole slew of new experiments to try. And don't worry; some of them will be featured in upcoming editions of this very newsletter.


